Executive Summary

Project Development Objective of National Agricultural Technology Program-Phase II Project (NATP-2) is to increase agricultural productivity of smallholder farms and improve smallholder farmer's access to markets in selected districts. In NATP-2 Hortex Foundation is the strategic partner to the Department of Agricultural Extension (DAE). As the strategic partner Hortex Foundation would assist the DAE's Common Interest Groups (CIG's), Producer organization (PO's) and private entrepreneurs through various measures. These are (i) organizing programmes for horizontal expansion of best practices in selected 30 old and new Upazilas (ii) mapping and organizing the vertical expansion of selected six high value crops-brinjal, sweet gourd, bitter gourd, tomato/summer tomato, banana and aromatic rice (iii) conduct value chain analysis, market studies and surveys (iv) undertake marketing capacity building for CIGs, POs, DAE and Hortex staff/officials on value chain management, organize and assist POs in establishing the Commodity Collection & Marketing Centres (CCMCs) as well as collection points (CPs), with good post harvest management and short term storing facilities where producers (both CIGs & non CIGs), processors and traders come together and are doing business (v) develop market linkages and contractual agreements between CIGs/POs with traders, supermarkets, processors and exporters (vi) provide financial advisory services to the CIGs/POs and entrepreneurs to apply for matching grants from AIF-2 & AIF-3 and (vii) organize communication campaign on food safety & SPS. Under the strategic partner contract, NATP-2 will support horizontal and vertical expansion of high value crops and large scale production of six selected aforesaid crops earlier covering 30 clusters in 30 upazilas of 22 districts. As strategic partner Hortex Foundation in association with DAE will organize farmers into value chain cluster based production and marketing chains to avoid over supply to markets during the peak production season, organize contract farming, production planning, business planning and establishment of CCMC and collection points with good post harvest management, packaging and transportation.

To contribute the above mention project objectives successfully, these are depends on a comprehensive program of training and related activities like institutional activity build up among the producer level, motivational campaign on agro-business, food safety, production and business planning, market linkage facilitation with traders, exposure visits, local level workshops, national workshops/seminars etc. Above mentioned events has been implemented at various levels in order to cover skill development, knowledge sharing as well as learning of different stakeholders during my 35 man months tenure since project inception. As training management expert in my first 24 man months tenure I had developed training methods, modules, manuals and training schedules, facilitated training, arranged workshops, seminars with the help of my other colleagues and Hortex administration. In the last fiscal year I have joined my second tenure as Training Management Expert on 1 November 2021 and from that day the events highlighted in RDPP like capacity building training of CIGs and POs, small scale food processing training for women CIGs, briefing on registration and by-laws development, business planning workshop for POs and national workshop has been

completed successfully within the targeted schedule with the help of Hortex administration and my other colleagues. In financial year 2022-23 my tenure was 03 man month only (July – September) and within this period one event named Market Linkage Facilitation Meeting for PO-MMCs with traders and exporters in each 30 upazila has completed till to the end of my second tenure on 30 September 2023. Although I have been contracted as Training Management Expert for 12 man month according to RDPP of NATP-2, but budget provision remained for me only 11 month. So I have finished my second tenure after 11 month instead of 12 month. Only one training related event such as 'Public relation & communication campaigns on food safety' remained unfinished during my second tenure because allocated budget for such event released on the last working day of my tenure. Since delayed budget released for the aforesaid event, it would be completed successfully with the help of other experts those are continuing their services and Hortex administration. Finally I express my deep gratitude to the Managing Director, Hortex Foundation for his kind cooperation. He has provided me all sorts' of logistics and moral supports during my working period. Me also express gratefulness to my other experts colleagues, officers and office staffs of Hortex Foundation, projects officials of PIU, PMU and officers of DAE, those are working at upazila, districts and regional level too for their hearty cooperation to finish my tasks timely and successfully.

Methodology Followed:

To implement training events methodologies were as follows:-

- 1. Training Need Assessment (TNA): Though training events has been analysed methodically and training programme has already started but TNA could not be carried out in its usual method because the mobilization of the project was delayed by almost two years. However the most of the Training Need Assessment was categorically pointed out by the project document (DPP) and the PAD of the World Bank and the areas of skills training for value chain development for CIGs, POs, traders and DAE officials were mentioned. The topics were mentioned as a directive for all the training events. Coverage of the topic was determined by consulting other experts and resource persons.
- 2. Training Courses Design: According to the subjects, duration and participants level which has been mentioned in activities in DPP/RDPP training courses has designed accordingly.
- 3. Implementation: In this report DPP/RDPP mentioned numbers of training and related events has already been implemented during my two consecutive tenure periods which has described detailed in major outputs sub title.
- 4. Evaluation of Training: To start any training session pre training evaluation and at the end of training session post training evaluation has done strictly with an appropriate questionnaire. But in case of CIGs and POs training programme emphasis was given on hands practices mainly so pre and post evaluation was not done in that sessions.

Outputs Other Than Training:

A Hortex team containing five members including me headed by Managing Director, Hortex Foundation went Kapasia upazila of Gazipur district on 24th December in 2017. There we visited CCMC at Chandpur bazaar which was constructed during NATP phase-1 project. Though it was completely constructed at that time but not functioning during visit that time. We discussed with the CIG's members, farmers, local market management committee members, SAAOs and UAO to find out the reasons why the CCMC was not functioning. Our team leader requested all concerned stakeholders to run the CCMC and he assured them to provide all sorts of logistic support from NATP-2 project. Local stakeholders assured us they will be taken necessary steps to become CCMC functioning.

As a member of the Hortex team I went Parbatipur upazila of Dinajpur district and visited CCMC at Khayerpukur bazaar on 17th January 2018. Our team leader was MD Hortex Foundation and all the team members took part in a discussion meeting held at CCMC with local CIG's members, traders, LBF, SAAOs and UAO. Khayerpukur bazaar CCMC also constructed in NATP phase-1 project like Kapasia. Though that CCMC was using but not in right way. Instead CIG farmers, local traders were accumulating their purchased goods in CCMC and packaging it as their traditional method and then loading it on the truck to carry. Our team leader discussed with the stakeholders those were present in the meeting and said this type of use is not the actual function the CCMC. He also requested them since some technological facilities would provide from the project so using such opportunities the stakeholders specially CIGs and non CIGs farmers should run the CCMC in right track for the betterment of their produced goods. Next day on 18th January 2018 we visited Birgonj & Chirirbandor upazila, Dinajpur. We met UAOs of both upazilas and collected up to date crop statistics and CIG formation report and also discussed about different kinds of training which would be done.

In order to run Chandpur bazaar CCMC in Kapasia upazila, Gazipur, concerned UAO invited our MD Hortex Foundation to attend a general meeting which was scheduled on 6th March 2018. MD Hortex Foundation requested me and my other colleague to visit Chandpur CCMC before general meeting to monitor their preparation for general meeting. Accordingly we the four experts headed by Dr. Mofarahus Sattar, M & E Expert went Kapasia upazila and met with UNO Kapasia accompanied by UAO and requested him on behalf of our MD to attend the forth coming general meeting. UNO assured us he would attend the aforesaid meeting. We also went at Chandpur bazaar with UAO Kapasia and took part a discussion meeting held at CCMC building regarding preparation progress for general meeting. We with the local CIG members, UAO, SAAOs and LBF selected the venue for 6th March general meeting and then turn back to Dhaka.

On 6th March 2018 at 6:30am we six member team headed by Managing Director, Hortex Foundation, firstly started from Dhaka to Kapasia and reached there at 9:30am. We met with UAO Kapasia at his office and want to know about the progress of preparation for general meeting. UAO told us that all the preparation for meeting has completed but due to national jute day celebration UNO has engaged in program so a little bit delay may occur. Just at

12:00 noon we started for Chandpur CCMC including UNO Kapasia, former MP and currently Chairman of upazila Awami Legue Mr. Shahiduzzaman and UAO Kapasia arrived there at 12:30pm. A successful meeting was hold at Chandpur bazaar nearby CCMC chaired by UNO Kapasia, chief guest was Mr. Md. Manjurul hannan, MD, Hortex Foundation and special guest was former MP. A market management committee was declared in that meeting to run the CCMC. UNO Kapasia, former MP and Local UP chairman assured us that all sorts of steps to be taken within shortest possible time to become CCMC functioning.

On 18th April 2018 on the way back from Jamalpur after completion of AAEO/SAAO training I went Delduar Upazila to select CCMC at Putiajani bazaar of Delduar Upazila. Accompanied by the UAO Delduar Upazila and my colleague Mr. Bazlur Rahman, Value Chain Integration and Marketing Expert jointly selected a semi pucca shade for CCMC at the aforesaid bazaar.

Likely on 15th May 2018 Mr. Mofarahus Sattar, M & E Expert and I together went at Kharokmara bazaar of Belabo Upazila and Lochonpur bazaar of Raipura Upazila respectively. We selected finally a semi pucca shade for CCMC at Kharokmara bazaar and a pucca structure for CCMC of Raipura Upazila at Lochonpur bazaar.

On 6th December 2018 I went at Tetulia bazaar of Barshail U/P of Naogaon Sadar upazila to visit and to assess the feasibility of proposed CCMC structure. Though the owner of the selected structure was not decided yet to give his structure for CCMC. I advised to the concerned LBF and UAO to finalise the matter soon.

Further I took part as a team member to prepare and finalize training modules for DAE and Hortex officer, booklet for CIGs farmers and leaflet on project summary, poster on value chain activities and other publications preparation. Not only above cited works, with the directives of the Managing Director, Hortex Foundation I took part a lot of project oriented activities as a team member of Hortex Foundation. During my working period I have visited several times each of of 30 CCMC and monitored CCMC's activities discussed with CIGs, PO-MMC members to enhance their value chain activities and encouraged them to gain AIF-2 as well as AIF-3. Further I visited different assigned upazila to monitor PO-MMC business progress, discussed with PO-MMC members and encouraged them to run agro business successfully.

Conclusion:

National Agricultural Technology Program-Phase II Project (NATP-2) is one sence a little bit mega project. It has many components out which DAE is the largest one. As Strategic Partner of the DAE, Hortex Foundation has assigned to work for improving value chain activities within selected 30 upazilas. Accordingly DPP/RDPP has mentioned different activities like establishment of CCMCs, collection points, renovation and construction of existing 10 markets, market study and surveys, value chain related logistic supports and different training programme for capacity buildings of persons of different sphere those are related to value chain activities, workshops, seminars, exposure visit, communication campaign on food safety etc. For Hortex Foundation DPP/RDPP has provision for 4 experts these are (i) Monitoring and Evaluation Expert (ii) Training Management Expert (iii) Postharvest Mamagement Expert (iv) Supply Chain Integration & Marketing Expert. Hortex Foundation authority recruited all experts in due time. Out of four except Training Management Expert other three expert's tenure is 60 man months but Training Management Expert's tenure was firstly 24 man months and later RDPP extended it to further 12 man months, total 36 months. Although RDPP extended further 12 man months tenure for me but budget provision kept 11 months only. So, my actual tenure was 35 man months only. DPP splited different events activities year wise likely year-1, year-2, year-3---- and so on accordingly budget allocation has shown. In case of training and its related different events splited in the DPP like year-1, year-2, year-3 even year-4 also but tenure period of training management expert mentioned in DPP two years only. It is one of the major shortfalls in the DPP. In hortex part a large number of different training and training related activities was mentioned in DPP which could not be possible at all to complete within two years. It was completely unrealistic. On the other hand selected 30 upazila for value chain activities was huge training programme, field days, demonstrations, exposure visit ctc.from main component of NATP-2 DAE and other projects also other than value chain one. Major activities of the NATP-2 project including training implementation area are at upazila level. All the UAO office of seclected 30 upazila has their own tightened training schedule. It was actually difficult to find the space for value chain training from their own departmental programme. Yet I persuded local DAE officers and got the opportunity to complete successfully the different kinds of training events, PO-MMC business planning workshops, exposure visits, market linkage facilitation meetings etc. mentioned in DPP as well as RDPP. It has been easier to complete my entire tasks successfully as a former DAE director as well as a training management expert. When hortex authority thrown any training program at the upazila some times UAO did not able to arrange that training in schedule date due to their own program but when I requested them they arranged our training programme even on the weekend holiday also. This type of favour I have got from many upazila officer so I am very grateful to them.

I express my deep gratefulness to Mr. Md. Manzarul Hannan, Managing Director Hortex Foundation because his kind directives and all sorts of logistic support in due course enable me to perform my duty within my tenure period. I also grateful to my other colleagues Dr. Mofaharus Sattar, monitoring and evaluation expert Mr. Md. Bazlur rahman, supply chain

integration and marketing expert and Dr. Md. Atiqur Rahman, postharvest management expert. All of them helped me in different training program attending physically at different training venues. I also expressed my gratitude to Mr. Mitul Kr. saha, Joint Director (Marketing), Hortex Foundation, Mr. Md. Mamun Hossain, Postharvest & Quality Assurance Specialist and Mr. Biplab Kr. Das, Accounts Officer, NATP-2 and other officials and staffs of hortex foundation for their hearty cooperation during my working period. I also expressed my gratefulness to DAE officers who are working at 30 selected upazila, districts, regions, officers of PIU, DAE, PMU for their close cooperation during my working period.

B. Context of the Assignment

Agriculture in Bangladesh comprises crops, livestock and fisheries. It provides food, feed, fiber and fuel to its citizens and animals, and plays a key role in economic development of Bangladesh. For achieving the set goal of SDG and turning Bangladesh into a middle income country by the 2021, the GDP has to grow by 7.4% per year. To attain the rate and to keep pace with the population growth, agriculture must grow at a constant rate of minimum 3-3.5% per year. Reaching technologies to the farmers requires technology generation and dissemination through the research and extension systems. National Agricultural Research System (NARS) is responsible for generating agricultural related technologies and Department of Agriculture Extension (DAE), Department of Fisheries (DOF) and Department of Livestock Services (DLS) are responsible for extension of generated technology to the farmers. Both research and extension have made an impressive contribution to food security in the country. In Bangladesh, private investment in research and extension is low. The NGOs, local government and community organizations are coming up but very slowly.

Bangladesh agriculture faces many challenges today. Major challenges are to raise productivity and profitability, reduce high production costs, increase price of products and resource-use efficiency, halt declining and degradation of soil resources and declining of animal and fisheries resources, adaptation to climate change vulnerability, providing consumers safe food, yield gap minimization, expansion of irrigation facilities & farm mechanization, production & distribution of quality seeds/varieties/ breeds/fingerlings, quality production of horticultural crop, popularization of good agricultural & IPM practices, weak linkage of farm-produces with market, low investment in agriculture and inadequate credit support to farmers. These challenges have stagnated the agricultural productivity and production. Further, nutrition outcomes and food safety have not kept pace with the progress achieved with most social and economic indicators. Thus, in order to produce more food for an ever increasing population, raw materials for agro-industries and higher income for farming communities from the decreasing resources (land, water, animal and fisheries), it is necessary to develop existing agricultural production system into a more dynamic, market oriented and sustainable commercial sector by higher productivity and profitability through

efficient natural resources management, irrigation expansion, agricultural intensification and diversification, mechanization, value addition and effective market linkages.

To that effect, the Government of Bangladesh (GoB) gives top priority to the development of agriculture sector through its increased productivity, production, supply chains, value addition and market linkages. GoB sought the support of development partners such as the World Bank to provide technical and financial support to activities aimed at boosting agricultural production through productivity enhancement, and increasing smallholders' income. In order to improve agricultural productivity and farm income, on the request of the Government of Bangladesh, the World Bank agreed to support a long term agricultural development program over a period of 15 years to be implemented in three phases of five years each with the first phase beginning in July 2007. IFAD also agreed to co-finance the program with the World Bank. Accordingly, the National Agricultural Technology Project (NATP): Phase-I (NATP-1) was designed with the development objective of improving the effectiveness of national agricultural technology system (including agricultural research, extension and development of supply chains) and increasing agricultural productivity and farm income in Bangladesh. NATP-1 was initiated in July 2007 and closed in December 2014. NATP-1 has significant achievements in generating technologies, increasing the effectiveness of extension and research systems, development of supply chains and broadening linkages between research-extension-farmers across the project areas. Based on the experience of NATP-1, the World Bank, jointly with IFAD and USAID, decided to provide financial support to GoB for National Agricultural Technology Program- Phase II Project (NATP-2). The duration of the project is 01 October 2015 to 30 September 2021.

C. Project Development Objective

Project Development Objective (PDO) of National Agricultural Technology Program-Phase II Project (NATP-2) is to increase agricultural productivity of smallholder farms and improve smallholder farmers' access to markets in selected districts. PDO will be achieved through: a) strengthening the capacity of research, extension services and farmers to generate, diffuse and adopt agricultural technologies aimed at increasing farm productivity and reducing post-harvest losses; and b) promoting the sustainability of existing and newly created farmer groups and producer organizations by facilitating their stronger participation in commodity value chain, market-linkages, and improving their knowledge and skill base. Thus, the PDO will be achieved through the generation and release of more productive and locally adapted technologies, enhancing availability of quality seeds/breeds/fingerlings/ breeding materials at the small farm level and providing relevant production, value addition, food safety and marketing support.

D. Development of Value Chains in Crop/Horticulture

Strategic Partner

NATP-2 will support the Hortex Foundation as the Strategic Partner to Department of Agricultural Extension (DAE) under a Strategic Partner Agreement for providing technical services on value chain development with an agreed contract value of US\$ 3.50 million. The strategic partner would assist DAE's Common Interest Groups (CIGs) and Producer Organizations (POs), and private entrepreneurs in: i) organizing programs for horizontal expansion of best practices in selected 30 old and new generation upazilas and ii) mapping and organizing the vertical expansion of selected six crops, brinjal, bitter gourd, sweet gourd, tomato/summer tomato, banana and aromatic rice; iii) undertake value chain analysis, market

studies and surveys; iv) undertake marketing capacity building for CIG, POs and DAE staff/officials on value chain management, organize and assist POs in establishing the Commodity Collection & Marketing Centers(CCMCs) and renovation of existing markets with good post-harvest management and short term storing facilities where producers (CIGs and non-CIG farmers), processors and traders come together and are doing business; v) develop market linkages and contractual arrangements between CIGs/POs with traders, supermarkets, processor and exporter; vi) provide financial advisory services to CIG/POs and entrepreneurs to apply for matching grants from Agricultural Innovation Funds (AIF-2, technology adoption and AIF-3 for market and enterprises development); and vii) organize communication campaign on food safety, SPS (Sanitary and Phytosanitary Standards), etc.

Value Chain Mapping

Under the strategic partner contract, project will support horizontal and vertical expansion of high value crops and large scale production of six selected crops (brinjal, bitter gourd, sweet gourd, tomato/summer tomato, banana and aromatic rice) covering 30 clusters in 30 upazilas of 22 districts. The strategic partner in association of DAE will organize farmers into value chain cluster based production and marketing chains to avoid over supply to markets during the peak production season, organize contract farming, production planning, and renovation and establishment of CCMC and collection points with good post-harvest management, packaging and transportation. Inclusion of specific crops in a cluster in horizontal or vertical expansion programs would be based on demand in local and export markets, comparative advantage of specific crop(s) in a cluster, marginal and small farmer's preference of the specific crop in the cluster, availability of technology and inputs for crop, transport/communication (road, rail, water) facility to urban markets and large scale production potentiality of a crop in a given cluster. In early years, there will be a strong emphasis on bridging the 'know-how' gap in the field on cluster based mapping and value chain analysis of selected crops.

E. Over All Objectives of the Assignment

To contribute to the Project objectives and help in scaling up, NATP-2 implementation will rely on a comprehensive program of training activities; this will be implemented at various levels and cover skill development, knowledge sharing and learning of different stakeholders. He will be responsible for developing training modules and manuals as well as conducting training, workshop, seminar, exposure visit, overseas study visit programs and ensure their implementation. He will also perform all project related training and communication activities in a timely manner.

F. Duties and Responsibilities
